AXIA Ventures Group acts as Joint-Bookrunner for Eurobank Ergasias S.A's €2,039 million Capital Increase

Athens, Greece – December 15th, 2015 – Eurobank Ergasias S.A. (the "Bank") announced on November 30th, 2015, the completion of the share capital increase of a total amount of €2,039 million via abolition of the preemption rights of the existing shareholders, through: (i) payment in cash of an amount of €1,621,150,153 via a private placement to qualified and other eligible investors, and (ii) capitalization of the monetary claims of an amount of €417,769,847 in the context of the voluntary exchange of existing securities by their holders that participated in the Liability Management Exercise.

This Offering concluded the Capital Raising Plan of the Bank and covered in full its total recapitalization requirement under the Adverse Scenario of the SSM's Comprehensive Assessment, exclusively through private investor participation.
